The Protocol consists of an Administration Manual, a Question-by-Question Guide, a Questionnaire, Response Cards, and a report of the psychometric properties of the Questionnaire. The Questionnaire consists of seven parts or modules: Demographics, Service Use, Employment, Community Life, Quality of Life, Well-Being, and Program Satisfaction. Use of the Protocol can assist peer-run programs in evaluating their services/supports, improving their programming, and reporting their successes to funding bodies and public entities.
